2. The committee will provide written advice of the decision regarding your application. A tax invoice will be issued on confirmation of sponsorship approval and payment is required no later than one month from the invoice date to secure sponsorship/exhibitor entitlements.
3. All official application and indemnity forms must be received before Friday 7th June 2019, unless prior arrangements are made with the committee.
4. In the event that the sponsor chooses to cancel their participation, they must notify the committee in writing immediately. The sponsor agrees that the organiser shall retain 100% of the contract price if cancellation is received after 5th July 2019.
5. No sponsor shall erect any signs, area, wall or obstruction which, in the opinion of the organisers, interferes with an adjoining exhibitor.
6. The sponsor hereby indemnifies and will keep indemnified, the committee against any liability, action, claim, demand, cost, charges or expenses, arising as a result of any act, omission, negligence or thing done or omitted by such exhibitor or any servant, representative, agent, invitee or licensee.
7. The committee reserves the right to use all sponsor names and any photographs, video or other representations of their products taken by the GCGS committee for promotional purposes, including but not limited to publication on our website, Facebook page, advertisements and brochures.
